Create an action plan for each selected QI.

- Your action plan will NOT be submitted to your state leader. Make sure to save and/or print a copy to share with them during an upcoming program visit.
- Remember to engage members of your advisory committee, students, parents and other supporters in owning and accomplishing the plan of action. You're not alone!



Summary of Best Practices

Be realistic

- You won't be able to tackle every growth opportunity in one year, stay focused on a few
- Consider your busiest times of the year when identifying an action plan

Soar with your strengths

• Remember that your growth plan can include areas of strength that you want to build upon

Make time to make it happen

- Sync up the action items with your personal organization system
- Coordinate with your teaching partners to meet and review progress regularly

Engage stakeholders

- Ask stakeholders for help with prioritizing the quality indicators to add to your growth plan
- Share your plan with stakeholders for input and ask for their help with certain action items
- Review progress with your advisory committee and other stakeholders on a regular basis
